


Figure 1. OPADE website structure

This is the gateway to the OPADE website. It includes a brief summary of the problem faced by the research project and how it intends to solve it.




Figure 4. Home section of OPADE website




Figure 8. News section of OPADE website

5.9. SSL certificate

The OPADE website has a Secure Sockets Layer (SSL) certificate, a digital certificate that guarantees the authenticity of the website, which means that the website is represented truthfully and visitors will find the content they expect. SSL encrypts communication between computers while the communication is in transit. Basically, once the receiving party takes possession of the communication on a web page or in their email inbox, they can read it. If someone intercepts the SSL-certified communication while it is in transit, it will be unreadable and meaningless.

This certificate indicates that any data transmitted between the website and its visitors will remain private and secure. This means that the website provides visitors with encryption designed to prevent hackers - or any other unwanted third party - from stealing their sensitive information, especially information that could lead to identity theft.
